## APPENDIX 1

### ELECTRIC FRANCHISE

Town ordinance grants to the Public Service Company, Inc., the right and authority to use the streets, alleys, avenues and ways of the Town for the purpose of manufacturing, transmitting, distributing and selling electricity in the Town, for a term of twenty-five (25) years. At least one copy of the ordinance shall be kept in the office of the Town Clerk.

## APPENDIX 2

### NATURAL GAS FRANCHISE

Town ordinance grants to the Oklahoma Natural Gas Company, the right and authority to use the streets, alleys, avenues and ways of the Town for the purpose of manufacturing, transmitting, distributing and selling natural gas in the Town, for a term of twenty-five (25) years. At least one copy of the ordinance shall be kept in the office of the Town Clerk.

## APPENDIX 3

### CABLE TELEVISION PERMIT

Ordinance adopted April 8, 2014, granting Cebridge Acquisitions, L.P. Inc., doing business as Sudden Link Communications, a nonexclusive permit to construct, operate and maintain a cable system within the Town for term of ten (10) years with right of renewal, providing conditions for the same, rates and liability. At least one copy of the ordinance shall be kept in the office or the Town Clerk.
