1. Call to order.

 - (a) Election of Chairman
 - (b) Election of Vice Chairman
 - (c) Election of Secretary

Motion was made by Norma Meyer to have the Chairman, Vice Chairman, and Secretary the same as it is for the Town and Porter Public Works Authority, which is Steve Dickey, Chairman, Norma Meyer, Vice Chairman, and Shirley Herring, Secretary. He said the adjoining property owners have to be notified, the proposed rezoning must be published in a newspaper, and a public hearing has to be held concerning the proposed rezoning. (f) Approval of a building permit for Carolyn Brittain to place an RV temporarily on her property located at 710 W. Finale Avenue, Lot 10.

Chairman Steve Dickey said this property is not in compliance with the Planning and Zoning Codes. Motion was made by Steve Dickey to not approve a building permit for Carolyn Brittain to place an RV temporarily on her property located at 710 W. Finale Avenue, Lot 10. (g) Approval of a building permit for Dale Holloway to place 6 tiny houses on his property located on North 6th Street between Jersy Glo Avenue and Keystone Avenue.

Dale Holloway appeared before the Committee. Mr. Holloway said he has 12 lots. He said he would like to place 1 tiny house on 2 lots, for a total of 6 houses on the 12 lots. Mr. Holloway said the houses will be built off site and moved onto the property.

Motion was made by Bradah Littlefield to approve a building permit for Dale Holloway to place 6 tiny houses on his property located on North 6th Street between Jersy Glo Avenue and Keystone Avenue. The motion was seconded by Kevin Walker. Voted yes: Bradah Littlefield, Norma Meyer, Steve Dickey, Kevin Walker, and Lucas Beaty. Voted no: None. Motion carried.

(h) Approval of a building permit for Dahlita Tracy to build a new home on her property located at 337 W. Dixieland Avenue.

No action was taken on this item.

(i) Approval of a building permit for William Kilgore to place a manufactured home and a shed on property located at 318 South P Street.

Chairman Steve Dickey said some mobile homes have already been moved onto this property without permits being approved.

Motion was made by Steve Dickey to refer this matter to the Town attorney. The motion was seconded by Bradah Littlefield. Voted yes: Bradah Littlefield, Norma Meyer, Steve Dickey, Kevin Walker, and Lucas Beaty. Voted no: None. Motion carried.

(j) Approval of a building permit for Jordon Beck to place a manufactured home on the lots located next to 305 W. Dixieland Avenue.

Jordon Beck had submitted a picture of a sample home like the one he wants to place on his property. The Board members said they need a picture of the actual home Mr. Beck is going place on the property.
