1. Call to order.

Motion was made by Norma Meyer to allow people who owe a past due water bill to pay their current water bill plus a minimum of \$50.00 or 10% of the past due bill, whichever is greater, and if the payment is made by the 15th of the month, the last fee on the past due balance will be waived. The motion was seconded by Lucas Beaty. Voted yes: Bradah Littlefield, Norma Meyer, Steve Dickey, Kevin Walker, and Lucas Beaty. Voted no: None. Motion carried.

(g) Purchasing new set of tires for both one ton trucks.
